



CALL FOR NOMINATIONS

Stop TB Partnership Community Award 2021: Ending TB Stigma and Discrimination

Geneva, 27 July 2021

Stop TB Partnership is the leading agency supporting the meaningful engagement of TB affected communities and civil society in all aspects of the TB response. Each year Stop TB recognizes significant contributions from TB affected communities and civil society to the TB response in TB high burden settings, with the Stop TB Partnership Community Award.

Over the last three years this recognition has been for community mobilization for human rights, community led monitoring, grass roots peer support and TB community resilience in the face of COVID-19.

This year the focus is on work and commitments to ending TB stigma and discrimination. The successful nominee/s, chosen by the selection panel, will have demonstrated innovation and commitment to advance efforts to end TB stigma and discrimination in high TB country settings. We are very happy to be joined this year by the Humana People to People Foundation as co-supporters of this award.

We are calling on TB civil society, TB affected communities and other stakeholders to nominate an organization, network or coalition, particularly from TB affected populations, that has done significant and meaningful work towards ending TB stigma and discrimination that merits recognition.

Stigma and discrimination can manifest in different ways and can impact different people in different ways. Stigma and discrimination have a broad impact as a barrier in the TB response, including in families, communities, health care settings, education and occupational settings.

How to Nominate:

Please send a one-sided A4 page (maximum) nomination for TB affected community and/or civil society organizations / networks who have effectively advanced efforts to end TB stigma and discrimination. Please use the template found here to provide your nomination.

Please send the completed nominations template to CRG@stoptb.org by 18:00 Geneva time (CEST) on 22 August 2021. Incomplete nominations, or nominations received after this time, will not be considered.

A selection panel will determine the Awardee/s. The winners will be announced during the Stop TB Partnership Board Meeting in September 2021.





Eligibility:

- The nominee should be a TB affected community or civil society organization (coalitions or partnerships including these groups can nominate).
- The nominee should have undertaken meaningful and impactful work relating to TB stigma and/or discrimination.
- The nominee should be working and registered in a TB high burden country (if a network is not registered, they should have a Memorandum of Understanding with a registered organization in country).
- The award winner will also need to demonstrate how the prize money will go to support TB affected communities, to strengthen national or sub national networks of people affected by TB.

Selection Process:

All nominations will be reviewed by the selection panel. The scoring will be based on:

- Impact to address, reduce and progress towards ending TB stigma and discrimination
 Significance and degree of the contribution and change made in the spirit of CRG
- Innovation and partnerships
- Whether contribution or project was made through a grant, leveraged existing resources, or was voluntary.
- Potential to leverage the change /contribution going forward / sustainability.
