

CFCS Round 10 Frequently Asked Questions

Can I submit an application in a language other than English?

All applications must be submitted in English.

Can I submit an application for both Track 1 and Track 2?

Yes, the same organisation can submit an application for both Track 1 (Country) and Track 2 (Regional), however it is not likely that the same organization will get 2 grants

Why are some countries included in Round 10 that were not included in previous years?

The list of eligible countries for each round is determined by the CFCS donors. We hope to continue expanding the list for future rounds of funding.

Are international organisations or UN agencies (including regional/country offices) eligible to apply? International organisations are not eligible to apply for CFCS funding however they can partner with civil society and community partners to achieve project goals.

Are for-profit organisations eligible to apply?

For-profit organisations cannot be the principal applicant for CFCS funding. However, for-profit organisations can work in partnership with civil society and/or community organisations for the grant. Alternatively, if a for-profit organisation has a non-profit arm, this non-profit arm may apply for CFCS funding provided they are able to provide the required supporting documentation and meet the eligibility criteria.

What are the eligibility criteria?

Please check the CFCS Information Note for details on eligibility to determine whether your organisation meets the criteria.

What is the implementation period for the grants?

Grant implementation is for a period of one year, from the date of signing of the agreement. We envisage grants will start in July, 2021

How do I start or return to my application?

You must create your own username and password on the application website (<u>http://www.stoptb.org/global/awards/cfcs/r10/default.asp</u>) under "Not yet an applicant…". With your username and password you can access your application at any point, up until 21 May 18:00 (CEST).

I applied for a previous round of funding from CFCS – can I use the same username and password? *You will need to create a new login specifically for Round 10, with a new username and password.*



What do I do if I forget my username and password?

You will receive an email from <u>cfcs@stoptb.org</u> with your username and password. If you forget your login details, please search for this email in your inbox first. If you are unable to locate this email, please write to <u>cfcs@stoptb.org</u> to request assistance.

How can I complete the Workplan/Budget template with more activities and objectives?

You can insert additional rows to the Excel document to add more Objectives and Activities.

What should I include in column F "Deliverables" of the Workplan/Budget template?

Deliverables are the products of an activity. For example if your activity is to organize a community training session on the UNHLM 2022 targets, the deliverables could include a training report, an action plan etc. Deliverables can also be tangible products, such as 50 translated copies of A Deadly Divide Call to Action in your local language.

What are Indirect costs, and can we include HR costs?

HR costs which can be directly associated with the grant should be treated as direct costs and included under grant activities. This can also include a separate HR budget line for personnel working on grant activities, support roles, etc. (if not full time then as a %).

Indirect costs are limited to 10% and are operational costs e.g. common costs, licenses and certifications, administration costs, IT infrastructure, etc.

Can you please clarify the "Letter of support from the regional civil society or affected community organisations/networks if this is a national application" listed under optional Supporting Documentation?

For Track 1 applications, you can choose to upload a letter of support from regional networks/organisations, which would indicate their support, either formally or informally. This it could be relevant if you currently collaborate with the network informally, disseminate information to this network, or foresee a potential and formal partnership with this network in the CFCS proposal.
