PROBLEM STATEMENT — How to build capacities in civil society in the knowledge and advocacy for the implementation of public policies in TB in two key vulnerable populations in Latin America and the Caribbean: People in prisons and Migrants?

AIM — To build civil society capacity in the knowledge, advocacy, and implementation of public policies and projects that will benefit access to health and human rights of two key vulnerable populations in Latin America and the Caribbean: People in prisons and Migrants.

OBJECTIVES

To coordinate efforts to Latin American and Caribbean (LAC) countries to improve awareness, facilitate the understanding of the current state of TB morbidity and mortality within people in prisons and migrant populations, and share best community-based practices.

STRATEGIC ALIGNMENTS



CONTRIBUTION TO REACHING KEY <u>UN HLM TARGETS</u> BY 2022. The project seeks to promote and support an end to stigma and all forms of discrimination through advocacy in TB public policies and the protection and promotion of human rights. Recognizes the various sociocultural barriers and conditions that limit the TB control, especially in two TB key populations (people in prisons and migrants) and considering the need to develop integrated, people-centred and community-based health services.



ALIGNMENT WITH NATIONAL PRIORITIES AND THE TB STRATEGIC PLAN. The current Multisectoral Strategic Plan for the national response to tuberculosis proposes, as one of its priority objectives, the approach to the most vulnerable and most exposed populations, who have living conditions that reduce the possibilities of contagion and development. Also, considering the reduction of the risk of disease transmission in institutions with internment regimes and high population concentration for long periods (such as prisons). Likewise, it is part of the objective of strengthening the organized participation of people directly involved in the TB problem, including civil society organizations.
