## **Background**

The Challenge Facility for Civil Society (CFCS) is the Stop TB Partnership's program for TB civil society and communities to end TB by 2030. It is a unique mechanism that provides grants, technical assistance, tools and resources to support TB-affected communities and grassroots civil society organisations to promote and protect human rights and gender equity, and end TB stigma and discrimination. The ultimate goal is to champion community leadership to overcome the barriers that prevent access to essential TB care and support services in order to achieve an equitable TB response.

#### Vision for Round 13

During the 2023 United Nations High Level Meeting on TB, countries committed to realising an equitable and rights-based TB response. CFCS Round 13 aims to support organisations of people affected by TB and civil society organisations to reduce barriers to quality TB care and support services to end TB by 2030. This will be achieved by securing political will, reducing the TB financing gap, increasing demand for new tools and approaches, enhancing ambition and accountability, strengthening engagement of key partners and establishing supportive legal and policy environments. Indicative activities that will be supported are included in section "Indicative Activities for Funding".

The Stop TB Partnership's Challenge Facility for Civil Society Round 13 is funded by the United States Agency for International Development and L'Initiative implemented by Expertise France.

# Eligibility Criteria, Available Funding, Timelines and Request for Clarifications

Before applying for CFCS Round 13, please read the following information carefully.

#### **Eligible Countries & Regions**

The following countries and regions are eligible to apply for funding under CFCS Round 13:

**Track 1:** Organisations from the following 42 countries can apply:

#### **Eligible Organisations**

Organisations must meet the following four (4) criteria to be eligible for CFCS Round 13:

- Legally registered in one of the above-mentioned countries (legal registration certificate to be made available).
  - a. **Track 1:** Country-level organisations must be registered in the same country where grant activities will be implemented;
  - b. **Track 2:** Global and regional organisations should be legally registered and/or predominantly work in the targeted countries listed under Track 1;

**Please note:** New organisations that are not yet legally registered can collaborate with another that is registered. A legally registered organisation which meets the eligibility criteria, can act as the applicant and can support the legal registration of the new organisation and strengthen its capacity. This is highly recommended for networks of people affected by TB.

- 2. Civil society and/or community-based organisation working in the above-mentioned countries or regions.

  Organisations/networks of people affected by TB are particularly encouraged to apply.
- 3. Be able to open a bank account in the applicant's legal name in the country of registration.
- 4. Currently working on TB and/or Community, Rights & Gender (CRG)-related work.

#### **Funding Tracks**

There are two tracks through which eligible organisations can apply for funding:

- Track 1 Country Applications
  - o Track 1A: for organisations (i.e. TB survivor networks) with up to four years TB / CRG experience
  - Track 1B: for organisations with more than four years TB / CRG experience
- Track 2 Global/Regional Applications.
  - Organisations that work predominantly in and across the targeted countries within a region listed above under Track 1 can be considered for regional applications.
  - Organisations that work in at least three of the eligible regions listed above can be considered for global applications.

**Please note**: Organisations cannot get funding from both tracks. The majority of CFCS Round 13 funding will be dedicated to Track 1.



#### **Available Funding**

• The total available amount for CFCS in 2025 is up to USD 19 million. Stop TB is committed to strengthening national responses and therefore the majority of funding will be awarded under Track 1.

The following funding ceilings apply:

- Track 1 Country Applications
  - o Track 1A: organisations with up to 4 years of TB and CRG experience: up to USD 50,000.
  - o Track 1B: organisations with more than 4 years of TB and CRG experience: up to USD 100,000.
- Track 2 Global or Regional Coordination Applications
  - o up to **USD 150,000**.

The final grant amount may vary across/within countries and/or regions.

#### **Grant Duration**

Grant duration is 12 months from the date of signing the agreement with Stop TB Partnership/UNOPS.

#### **Anticipated Timeline**

- <u>Call for Proposals</u> is open from 12 December 2024
- Application submission deadline: 18:00 Central European Time (CET) on 14 February 2025
- Clarifying questions (see below) submission deadline: 23 January 2025
- Information Session (see below): 28 January 2025
- Answers to clarifying questions published (see below): 31 January 2025
- Announcement of successful applicants: April 2025

# **Evaluation of Applications**

All submitted applications undergo a two-stage evaluation process.

### **Screening**

All applications are first screened against the following eligibility criteria:

- Organisation is from one of the listed eligible countries or regions
- Organisation meets the eligibility criteria (provided above eligible organisations)
- Completeness of application all sections and documents are complete, and all mandatory supporting documents have been provided.

#### **Evaluation**

All applications which are screened in based on the above eligibility criteria will then be evaluated by an independent evaluation committee against the following evaluation criteria. Each funding track will be evaluated independently.

Please note: organisations with up to 4 years of experience in the TB response (including in CRG, advocacy and community mobilisation) who apply for Track 1A will be evaluated separately.

**Please note:** the evaluation of Track 2 proposals will focus primarily on <u>coordination</u>, <u>advocacy</u> and <u>communication</u>, and <u>partnerships</u> across countries.



### **Indicative Activities for Funding**

Building off the evidence from country and regional level work, below are lists of indicative activities (provided for example purposes only) that are eligible for CFCS Round 13 funding and under each funding track.

#### **Track 1 - Country Track**

#### Sample CRG Intervention Areas under Track 1

#### High-level advocacy for bridging the TB financing gaps

- Efforts and advocacy to increase awareness on TB financing, gaps and the need for domestic resource mobilization to reach the UN HLM targets
- Advocacy aimed at increasing awareness on TB among stakeholders and key decision makers
- Advocacy to increase funding for research and development (R&D) and access to latest diagnostics and treatment for all
- Skills building for effective community-led advocacy

# Stronger, more active and capable people and movements, inclusive of TB KVP and affected people, committed to TB CRG

- Strengthening of community systems
- Increasing TB, gender, and rights literacy
- Strengthening partnerships and collaboration with strategic partners for CRG
- Coordination and collaboration with partners to increase voice and representation of TB stakeholders, including TB survivors and CSOs into national health related bodies, including but not limited to country coordination mechanisms (CCMs)

#### Increased demand, commitment and actions towards rights and gender-based TB responses

- Demand generation for DR TB services, new tools and approaches and vaccines
- Stigma reduction
- Promotion and the protection of the rights of people affected by TB

#### Strategic CRG information mainstreamed for improved care and support services

- CRG integration into national and regional plans, approaches & strategies
- CRG evidence generation
- Scale up of community-led monitoring for social accountability

Gender equity, a focus on key and vulnerable populations and community strengthening should be prioritised and integrated throughout project activities.



#### Track 2 - Global or Regional Coordination Track

#### Sample CRG Intervention Areas under Track 2

- Coordinated efforts and advocacy to increase awareness on TB financing gaps and the need for domestic resource mobilization to reach the UN HLM targets
- Advocacy aimed at increasing awareness of TB among stakeholders and key decision makers
- Coordination and collaboration between partners to amplify the voices and increase representation of TB stakeholders, including TB survivors and CSOs into national health related bodies, including but not limited to regional platforms and country coordination mechanisms (CCMs)
- Coordination to increase demand for DR TB services, new tools and approaches and vaccines
- Regional / global movement building, knowledge exchange and coordination ensuring linkages between community partners at national, regional and global levels.
- Coordinated advocacy on stigma elimination
