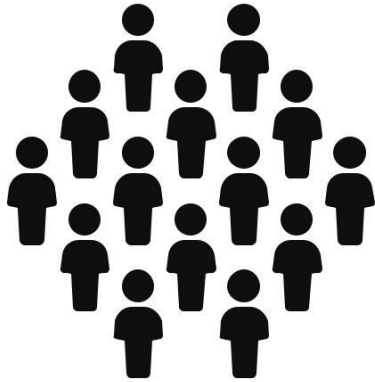

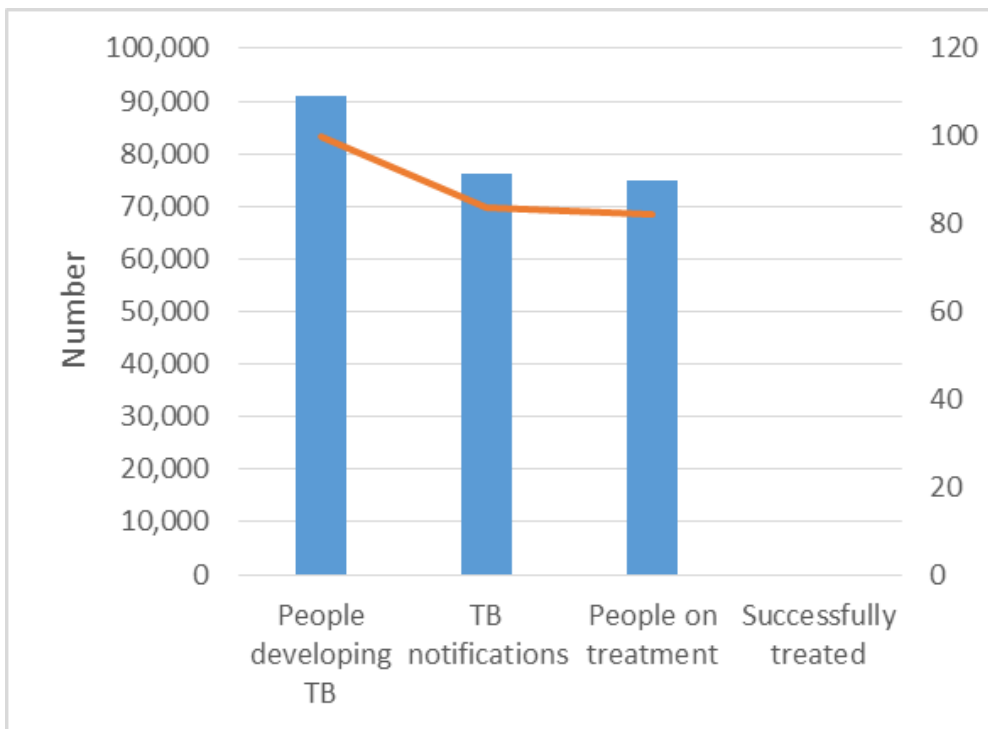

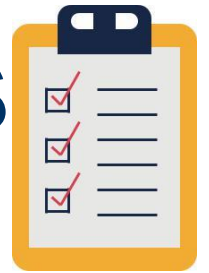

## The Registered Trustees of The Uganda Episcopal Conference (UEC)

**Project Location:** Zombo district.

**Timeline:**

**Overall aim:**

- To strengthen community resilience to combat Tuberculosis and thereby contribute to Universal Health Coverage for 20600 households in Zombo District from 2022 to 2023.

### **Proposal Objectives**

- To assess and integrate previously non-existent Community, Rights and Gender initiatives including screening and management of sexual and gender-based violence (SGBV) and violence against children (VAC) into TB services provided at 10 TB diagnostic and treatment centres in Zombo district West Nile by the end of 2023
- To improve availability, access and acceptability of high-quality TB awareness, prevention, diagnostic and treatment services for high-risk key and marginalized populations (persons with mental and physical disabilities, men, adolescents, orphans and vulnerable children (OVCs) among other children, incarcerated persons, tobacco users, people who inject drugs, health workers, diabetes patients and cross border populations) in Zombo district West Nile by the end of 2023
- To engage TB expert patients, survivors, men, women and Faith Leaders as community agents for client-led TB programming and gender equity in Zombo district by the end of 2023
- To participate and engage in TB advocacy and accountability initiatives at national, regional, and global levels.

## Grantees

### Uganda Stop TB Partnership

**Project Location:** Kampala Capital City.

**Timeline:** March 2023 – March 2024

**Aim:**

- To build a community model involving TB survivors and actors that can efficiently deliver TB services in five slums of Kampala within the project lifespan.

**Objectives:**

- To engage the Uganda TB parliamentary Caucus and government top decision makers for increased domestic funding and enabling health legislation for community action towards meeting the UNHLM targets by end of March 2024
- To support formation, registration of TB survivors' networks in the 5 major slums of Kampala and admission as members of Uganda Stop TB partnership by end of March 2024
- To engage the 50 TB survivors/TB affected persons from the 5 major slums in Kampala to do community TB monitoring to inform TB programming in the country by end of March 2024
- To participate and engage in TB advocacy and accountability initiatives at national, regional, and global levels



# Country-level Platform Partnership

## Uganda Stop TB Partnership

**Project Location:** Kampala Capital City

**Timeline:** November 2022-May 2024

**Overall Aim:**

- To strengthen advocacy, communication, coordination, and partnership initiatives with engagement of key stakeholders across sectors at different levels in Uganda to achieve commitments to end TB by 2030

**Proposal Objectives:**

- To enhance local and national partners engagement in TB response through partnership-
- To strengthen high-level advocacy efforts at national level to ensure alignment of national and global advocacy agenda.
- To enhance domestic financing and investment towards reaching country targets to end TB.
- To position USTP in the country- level platforms as a strategic leaders and key conveners and facilitators on TB.
- To increase the number of partners engaged in TB response at the country level and ensure the relevance of the partnership platforms.
- To conduct strong TB advocacy and create a critical mass to deliver change around TB issues.
